SUBMISSION INSTRUCTIONS FOR AUTHORS OF UNPUBLISHED EDITORIAL CONTENT

I. AREAS OF INTEREST

1. The *Journal of Family Law and Succession Law* (Portuguese acronym: RDFAS), ISSN 2358-2057, a quarterly journal published by the Family Law and Succession Law Society (ADFAS), based in São Paulo, Brazil, ranked as Qualis B-2 in the Brazilian scientific journal index, hereby announces a call for the submission of papers, legal opinions, commentaries on precedents and laws, as well as book reviews, covering the following topics

Family Law and Succession Law, Biolaw, Laws for the protection of children and youngsters, Elder Law, Disability Rights, as well as Civil Procedure, Notary and Registry Law, Social Security Laws, Labor Law, Corporate Law, Tax Law, Criminal Law, and other legal fields that relate to ADFAS's main areas of interest. Mediation, the History of Family and Succession Law, and other interdisciplinary topics in Psychology, Sociology, Anthropology, and Philosophy that are relevant to ADFAS's interests are also accepted.

II. PUBLICATION FORMAT

- 2 The journal will be published in digital and open access format on the RDFAS website www.adfas.org.br.
- **3.** Submission is open to all interested parties, regardless of whether they are members of ADFAS or not.

III. DEADLINE

4. Submissions for this call must be received by June 30, 2025. Texts received after this deadline will be considered for the next issue, unless the journal is devoted to a specific theme.

IV. SPECIFIC RULES FOR COMMENTARIES, REVIEWS AND OPINIONS

5. Submission of commentaries of precedents and laws, book reviews and legal opinions is allowed.

V. CONFLICTS OF INTEREST AND RESEARCH FUNDING

6. Any potential conflicts of interest must be disclosed. If the research was funded, the funding source must be indicated in a footnote.

VI. MINIMUM DEGREE REQUIREMENT FOR AUTHORS OF PAPERS

& Authors of the submitted papers must be either Master's or Doctoral students or hold a Master's or Doctoral degree. Authors or co-authors who do not possess any of these (i.e. undergraduate students or undergraduates) are still welcome to send book reviews and commentaries on precedents/case law.

VII. PUBLICATION FORMATTING REQUIREMENTS

- **9.** Papers shall comply with the following standards:
- (a) Paper size: A4;
- (b) Length: minimum of 10 and maximum of 40 pages, with 2,100 characters on each page excluding spaces, including footnotes and references (commentaries may be shorter than that);
- (c) Margins: 2.0 cm top and bottom, 3.0 cm left and right;
- (d) Alignment: justified;
- (e) Font: Times New Roman, 12 pt title, body, quotes and summary; 10 pt footnotes (endnotes are not allowed);
- (f) Line spacing: 1,5;
- (g) Italics for emphasis (do not use either bold or underline);
- (h) Quotations in quotation marks without indentation;
- (i) Paper title must be in English and Portuguese;
- (j) Five keywords in English and Portuguese;
- (k) Abstract in English and Portuguese, max. 750 characters excluding spaces; and
- (1) Table of contents.
- **10.** Author identification data must appear on a separate cover sheet:
- (a) Name, ID number, taxpaper number (CPF, if applicable), academic title to be published with the paper, and profession. The postgraduate title (field and institution) and the institution to which the author(s) are affiliated (university, school and department) must be provided.
- (b) Address, phone number, and email address of the author(s).

11. The paper and cover sheet must be submitted as separate files, named according to the paper title. Papers should not contain any author identification. This rule does not apply to commentaries, reviews, and legal opinions.

VIII. CITATION RULES

- **12.** The author-date citation system is not allowed.
- 13. Authors' first names must not be abbreviated in citations. Translated works must include the translator's name.
- 14. Citations of precedents must include the full reference: court, decision number, panel, judgment date, and publication source with respective date.
- 15. A final bibliography is required.

IX. ORIGINALITY AND ACCEPTED LANGUAGES FOR SUBMISSION

- 16. Only unpublished texts in Brazil will be reviewed by the Editorial Board, which may return submissions with suggested revisions.
- 17. Papers that were previously published abroad (as long as they remain unpublished in Brazil until its submission to RDFAS) are permitted.
- 18. Submissions may be written in either Portuguese, English, Spanish, French or Italian.

X. AUTHOR'S RIGHTS

19. Submission to RDFAS requires acceptance of the Copyright Transfer and Liability Agreement, which must be attached to the submission email (template attached to this document).

XI. AUTOMATION SYSTEMS

- 20. All content submitted to RDFAS must be written by humans, with no mechanical or artificial intelligence involvement.
- 21. The use of machine translation tools is also prohibited, including for the Abstract and Keywords. Submission of content implies acceptance of this rule and serves as a declaration of compliance with the journal's editorial policies.

The content shall be published or distributed by print or digital means, while ADFAS is authorized to include the editorial content in printed or digital media, online, intranet, internet, and hosting, whether standalone or combined with other works and electronic information services, on its own servers or those of third parties, via all currently existing or future electronic means, including temporary or permanent storage in user memory or drives, on mobile or fixed devices, portable or not.
